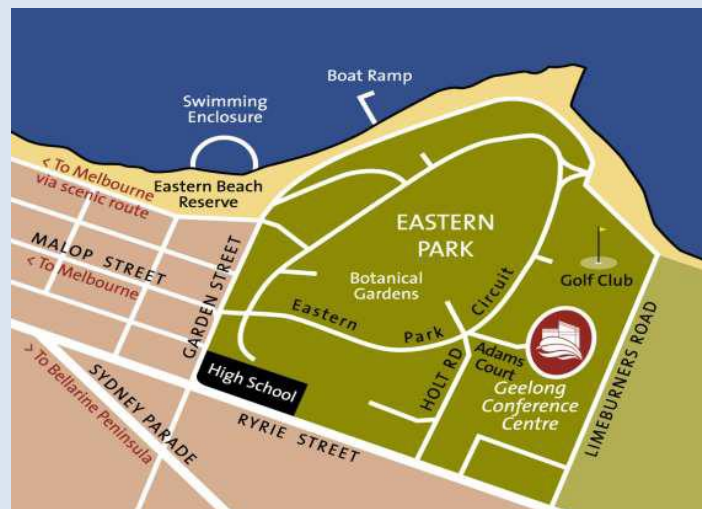

Information You Need to Know

- Associate members have no voting rights and are not eligible to hold office.
- Students are not required to pay an annual fee.
- Renewal of Membership is on 1 July each year. New members who join after March 1st and before June 30th pay the annual fee and receive up to three months membership free.
